Previously registered swimmers can join any one of the clubs listed above during the re-registration period of November 1, 2007 through December 31, 2008 without having to swim unattached for sixty days.

Some registered clubs have a designated Club Liaison Registrar. New swimmers wishing to affiliate with one of these clubs must send their new registrations to the Club Liaison Registrar not to the **GRIN** LMSC Registrar. Mail new registrations directly to the person indicated on the registration form. Swimmers renewing from 2007 may send their registration directly to the GRIN LMSC Registrar.

Each Club Liaison Registrar will process club information for its club before forwarding their club's new registrations to the **GRIN** LMSC Registrar. The **GRIN** LMSC Registrar will issue the USMS cards with the USMS numbers. It may take a little longer for a swimmer to receive his/her card from one of these clubs, so please be patient. Completed registration forms and checks for all other clubs and UNATTACHED may be sent directly to the **GRIN** LMSC Registrar. (USMS is in process of developing on line registration. It is not available now, but may be sometime during 2007.)

For swimmers wishing to join **GRIN**, the policy from previous years is still in effect. Swimmers may swim for a local group for recognized/sanctions meets within the **GRIN** LMSC boundary if the meet is not a National or Zone meet. Please indicate your local group if registering as **GRIN**. If a **GRIN** swimmer participates in an USMS meet that is a National Event or a Zone Event or outside of the **GRIN** LMSC boundary, the swimmer must designate **GRIN** as her/his competing club.

If a swimmer wishes to join as UNATTACHED, s/he cannot designate a local group for recognized/sanctioned meets within or outside of the **GRIN** LMSC boundary. If a swimmer wishes to transfer to a registered LMSC Club after registering as UNATTACHED, s/he may do so by applying for a transfer through the GRIN LMSC Registrar for a nominal fee.

Once a card has been issued by the **GRIN** LMSC Registrar for a specific club, a swimmer will have to swim unattached for sixty days and/or sign a waiver that s/he has not completed for his/her current club for sixty days if s/he wants to change affiliation. Contact the **GRIN** LMSC Registrar for the proper form. There will be a nominal fee for this transfer.

All USMS/LMSC registered swimmers, regardless of Club affiliation, receive all the benefits of USMS membership.

Please note: All swimmers must be from the same registered club if competing on a relay within or outside the GRIN LMSC boundary. UNATTACHED swimmers may not compete on relays.
